ELIGIBILITY CRITERIA

Artist Assist Program, Business Development Series: Aged +18, residing in Australia, Aboriginal and Torres Strait Islander, woman, transgender or non-binary. Actively working in Australian music for 12+ months, transitioning to full-time self-employment, OR established artist seeking growth or diversification. (Evidence of active work includes public performances, demos, or referrals from music-related organisations).

Note: "Emerging profile" indicates early career stage; "Established profile" refers to a recognised presence in the Australian music industry.

TERMS AND CONDITIONS

RESPECTFUL SHARING OF KNOWLEDGE

We respect you and your business, and we understand that the knowledge shared in these workshops may be commercially sensitive or confidential. Sharing is freely encouraged. Participating in these workshops is your agreement that you will respect the knowledge gained and not share without consent of the owner.

COMMITMENT TO THE PROGRAM

The Business Development Series requires a big commitment. For this program you will need to be onsite in Naarm (Melbourne) from 9am - 5pm on January 17th, 18th & 19th 2024.

There will be media, filming and photography opportunities that will be available throughout the series.

Each selected participant will be supplied with a \$500 bursary.

K&Co offers support to regional and interstate participants. This means K&Co will provide flights to and from Melbourne from your closest city/capital city airport. Hotel accommodation will be provided with breakfast. You will also be provided a per diem.

Melbourne and outer Melbourne participants will not be eligible for travel or accommodation support. You will need to make your own arrangements to attend the workshops.

Regional Victoria participants, if you need support with travel costs please let us know via assist@kennell.com.au K&Co will provide a tea & coffee station, and lunch catering.
